Question

- What role can local and regional authorities play in monitoring and addressing issues related to freedom of movement?
- What specific policies or programmes are needed to preserve and promote the linguistic and cultural heritage of the Former British Southern Cameroons?
- How can the Assemblies collaborate with cultural organizations to safeguard traditions, languages, and historical narratives?
- How should the process of designing and adopting regional symbols (flag, crest, anthem) be conducted to ensure they reflect the aspirations of the people?
- What criteria should be used to establish local commemorative days and ensure they are celebrated inclusively?
- What mechanisms are required to ensure the precedence of English in governance while promoting bilingualism and fostering inclusivity?
- How can English-language education and professional development programmes be strengthened to align with this principle?



- How can community members, including marginalised groups, be actively involved in shaping and implementing these reforms?
- What role should civil society organisations and traditional leaders play in promoting cultural preservation and citizenship reforms?
- What institutions or bodies should oversee the implementation of citizenship and cultural reforms to ensure compliance and address challenges?
- How can progress be measured and reported transparently to stakeholders, including citizens?
- How can the reforms ensure the cultural distinctiveness of Former British Southern Cameroons while fostering a shared national identity?
- What steps can be taken to prevent cultural preservation efforts from being perceived as exclusionary by other regions of Cameroon?
